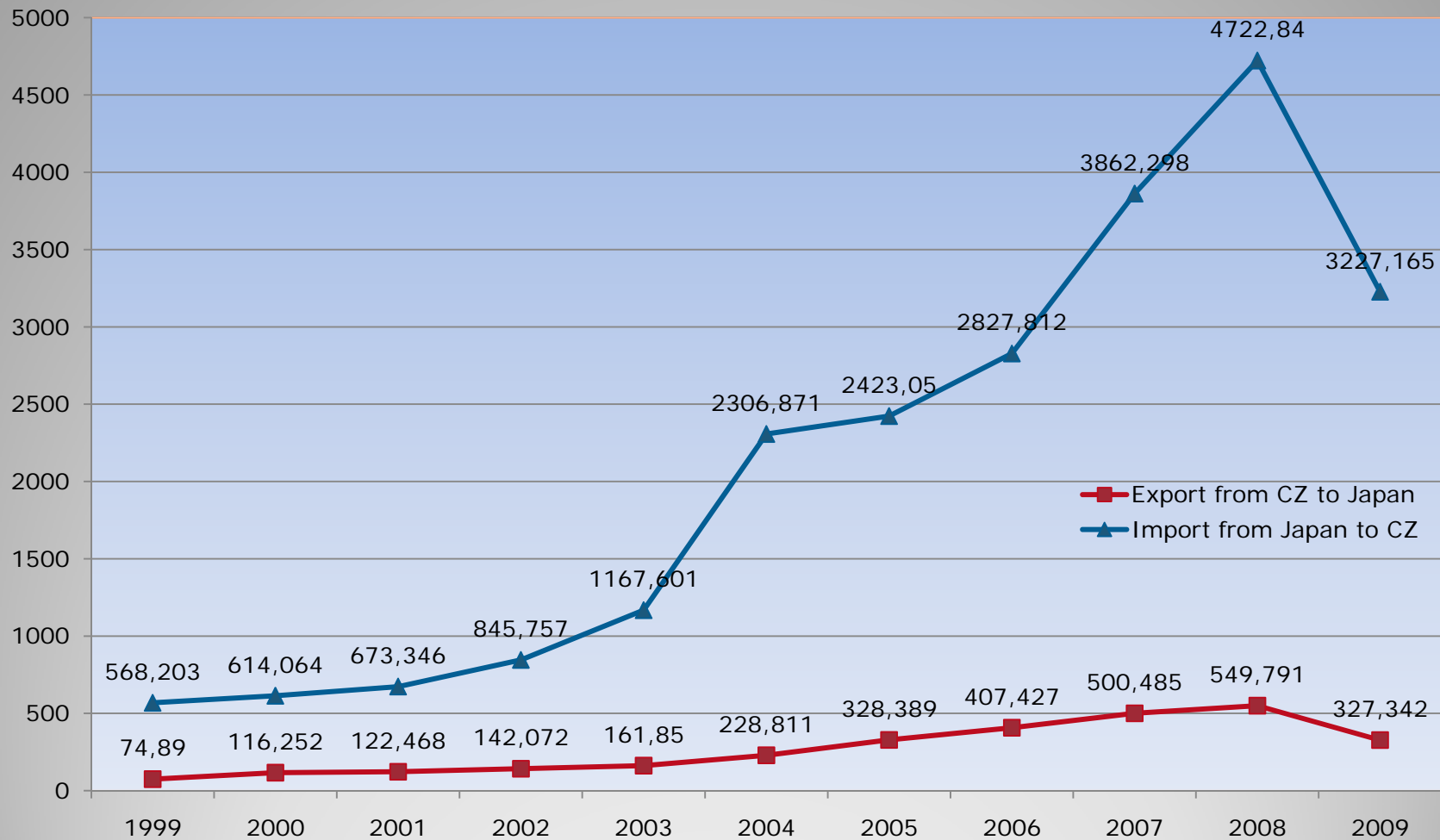

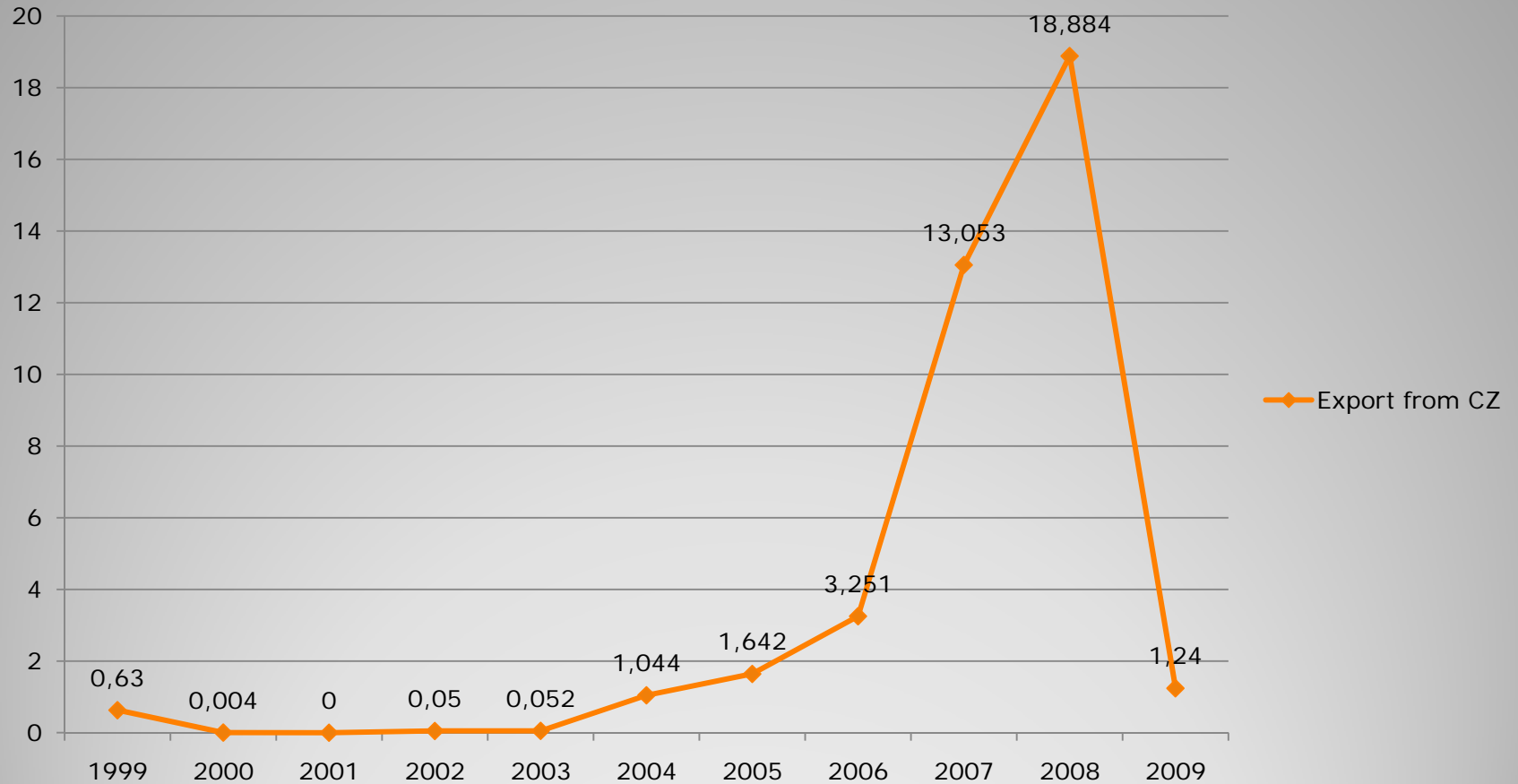

**Czech export of metal cutting and metal forming machines to Japan acc. to the custom tariff in 1999 - 2009 (mil. USD)**

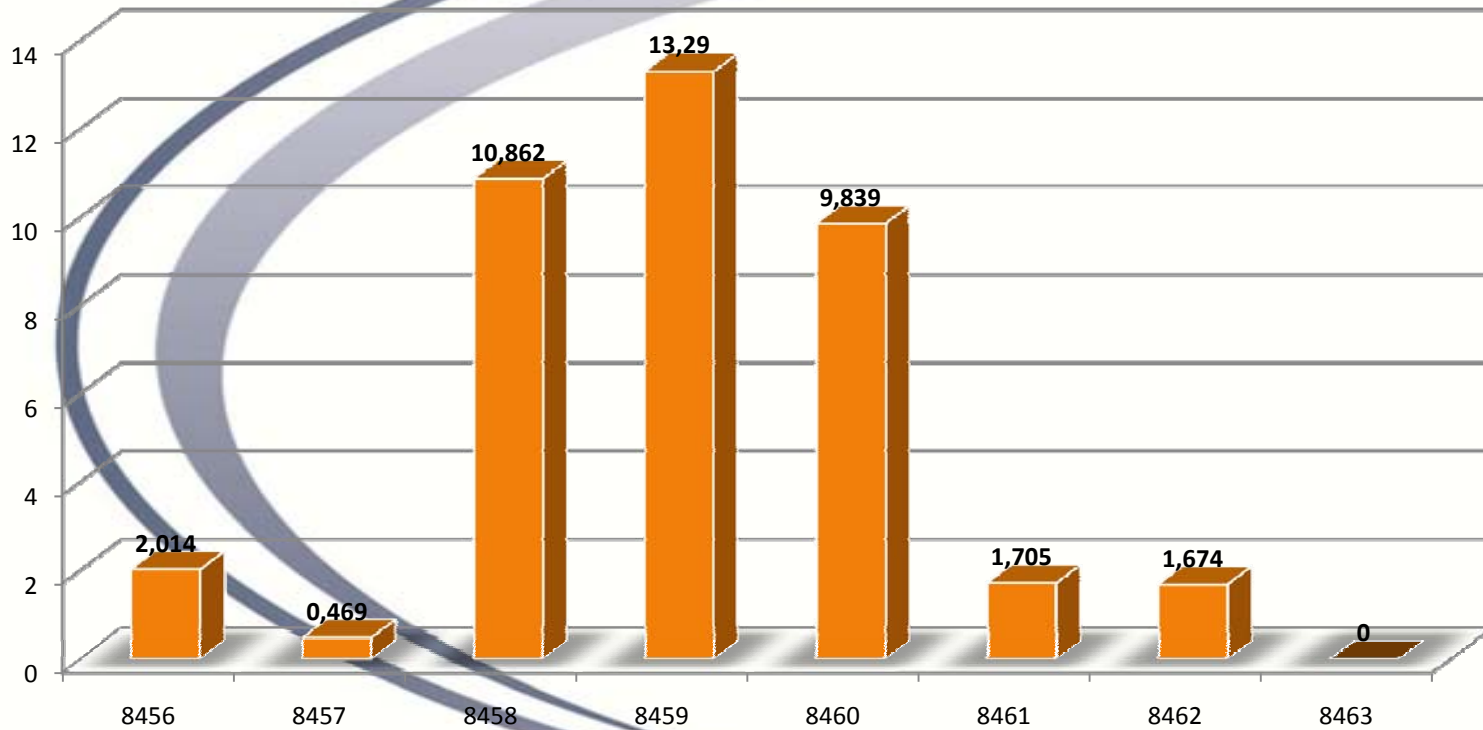

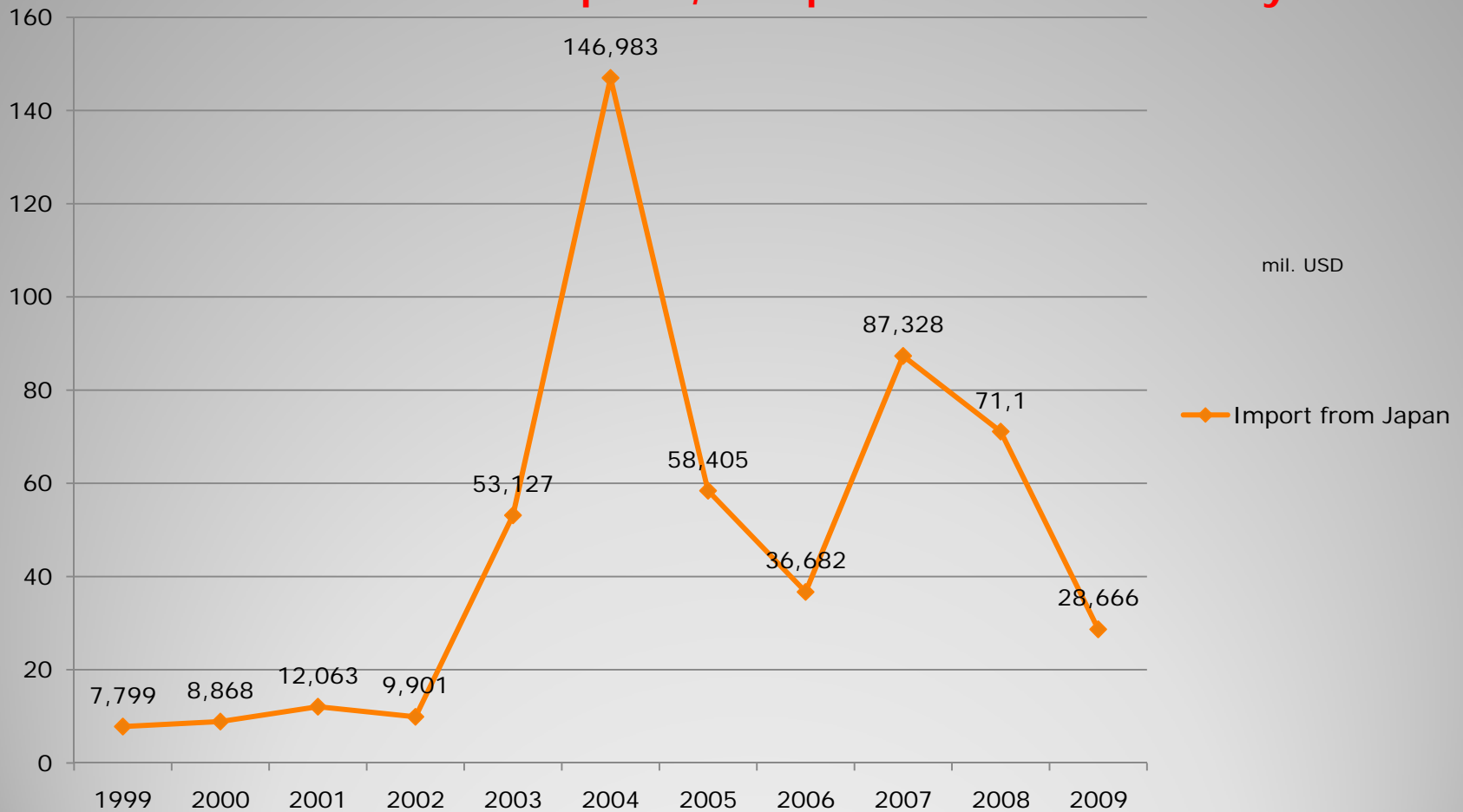

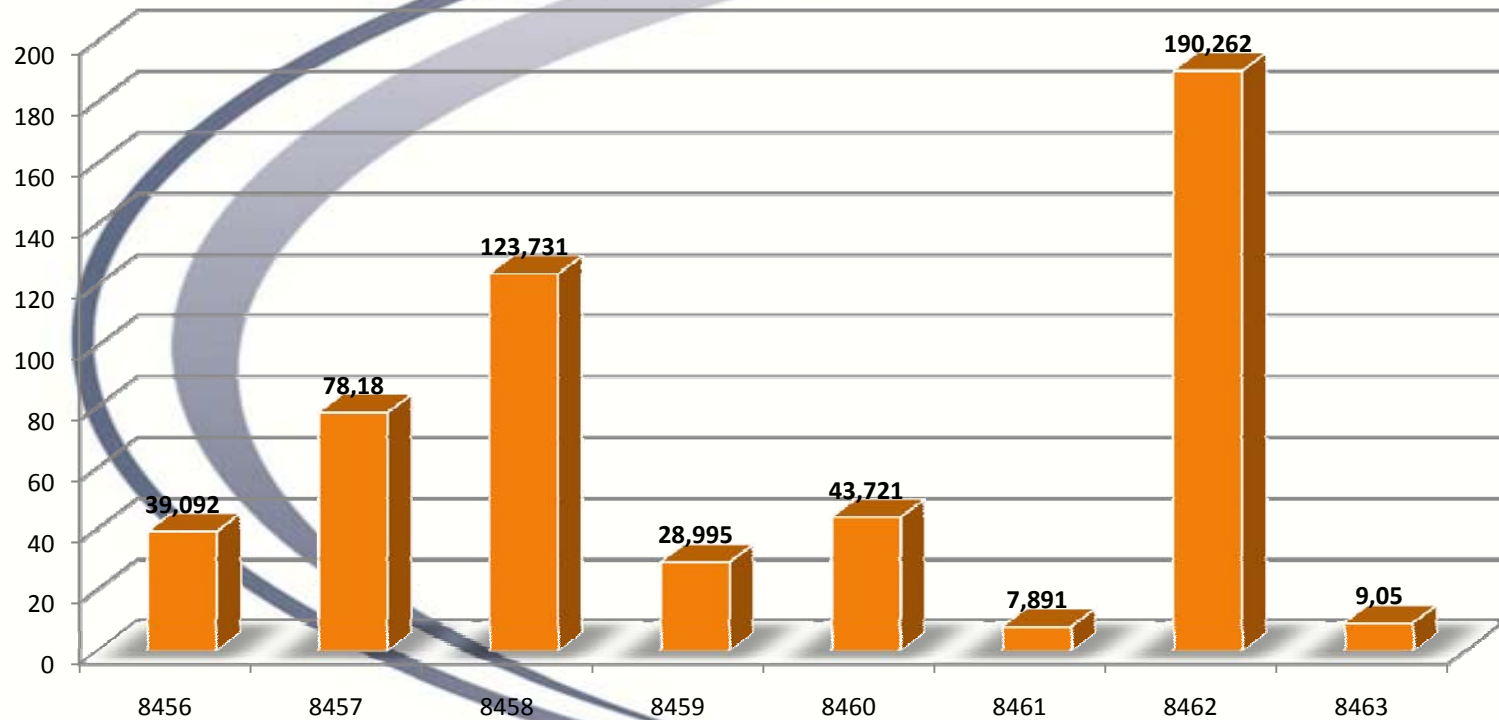

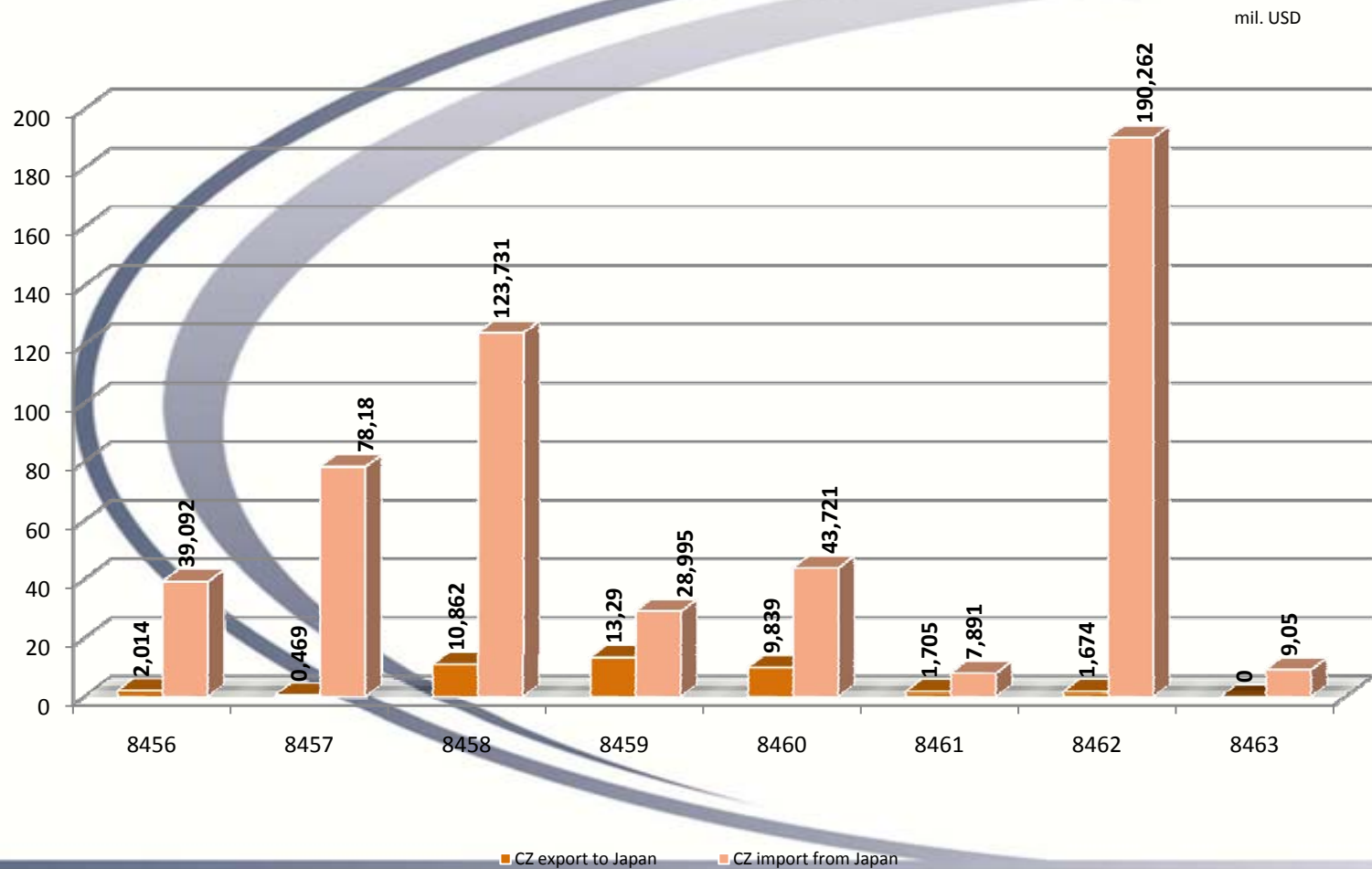
**Czech import of metal cutting and metal forming machines from Japan in 1999 - 2008**

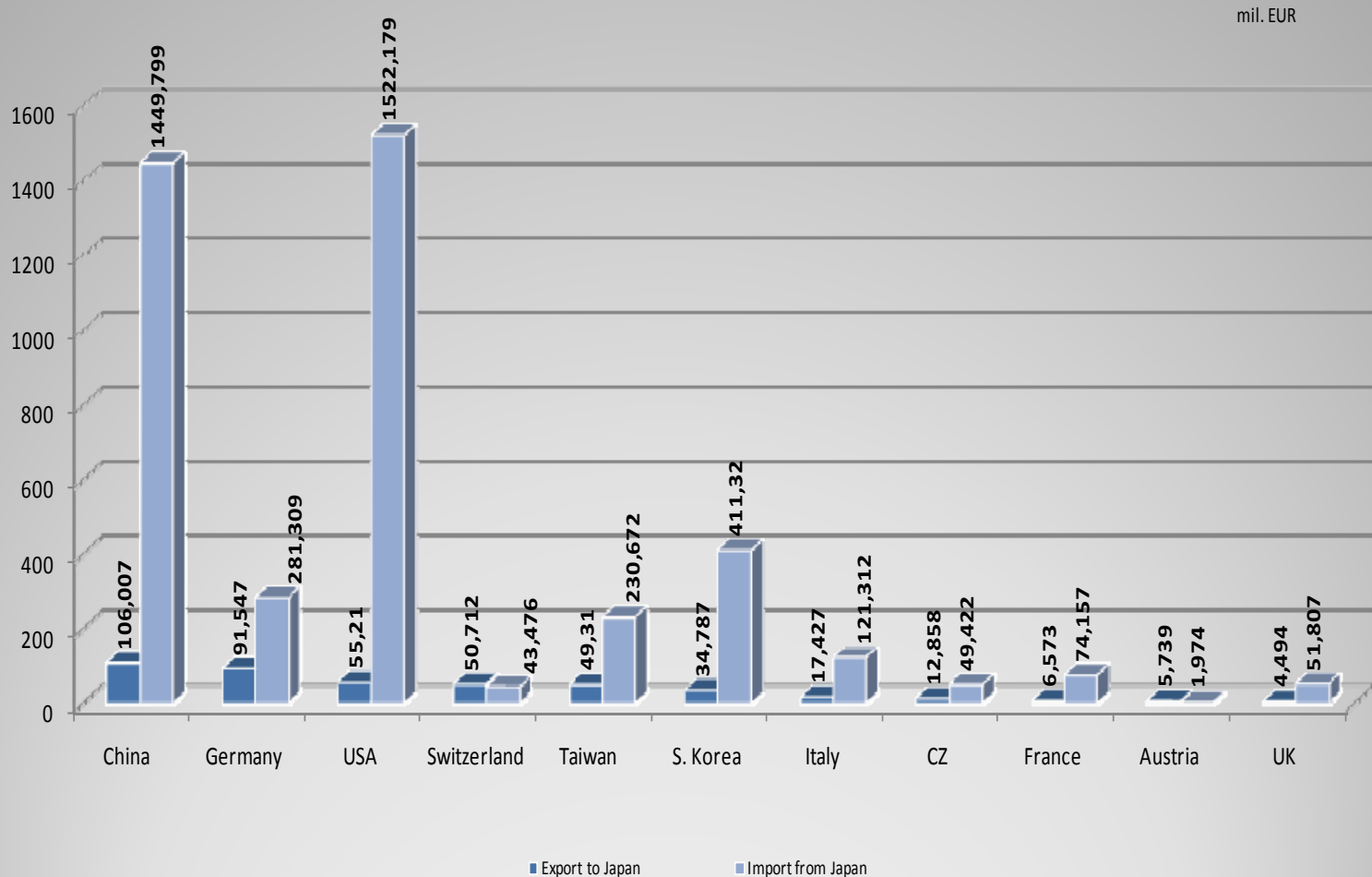

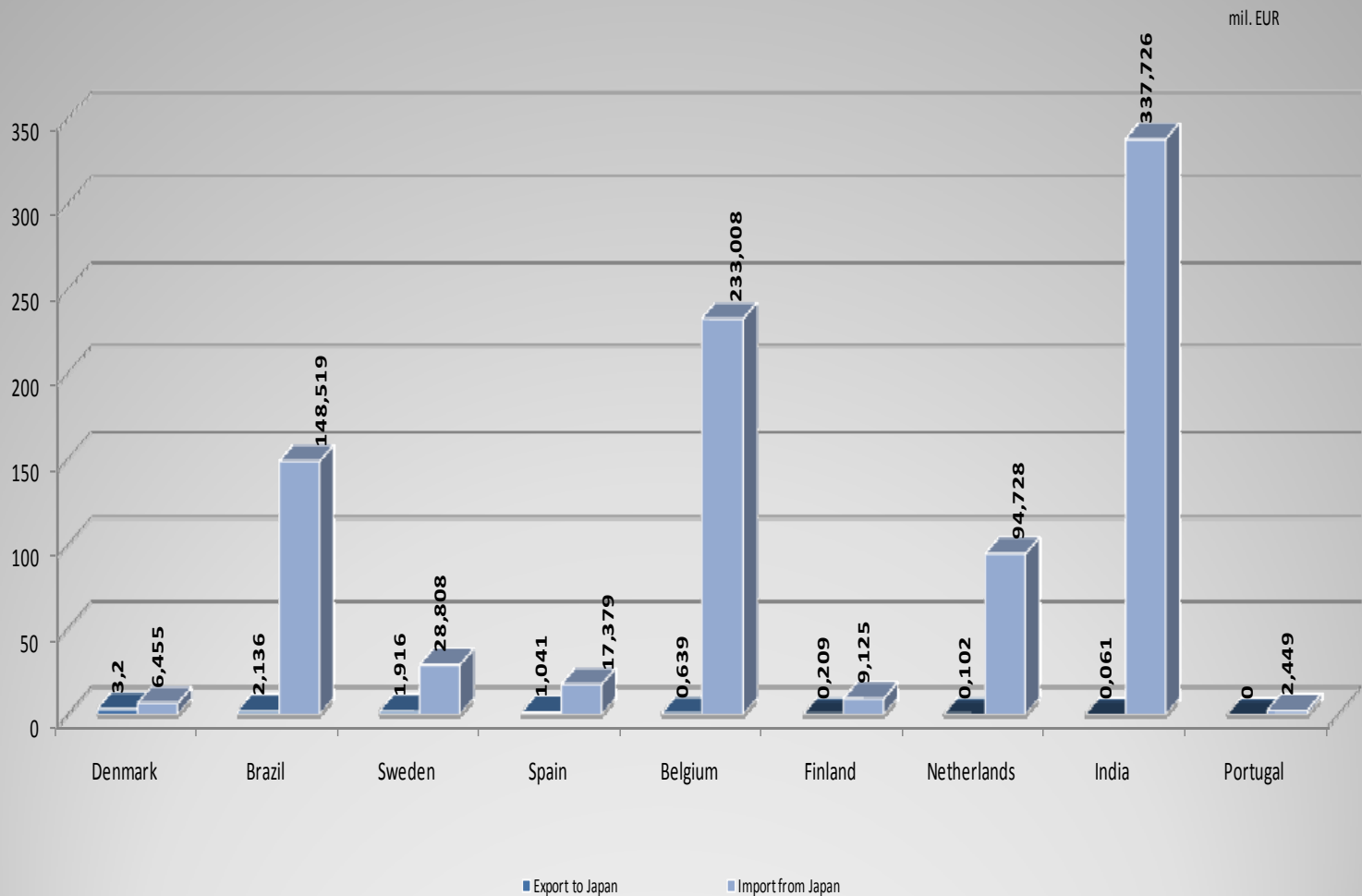
